
Encouraged by the profitability of these organizations and the economic growth, numerous figures and entities have been developed:


Investment on startups during 2014-2018








Total investment and investment on social startups during 2014-2018








Investment on social startups during 2014-2018







Investment on environmental services and equipment (2018)







How mobile are you?

With these Icons, Handiscover helps you find accommodations that really suit your needs.



You can walk and can handle going up a few stairs.

The accommodation is not fully accessible, and requires a maximum of 15 steps (1 floor up) to reach it or to manoeuvre within it.



You can only handle one step at a time.

The accommodation is quite accessible but not up to the latest accessibility standards. It can suit for example wheelchair users able to climb a stair/threshold of up to 15 cm (6 inches) at a time. See detailed accessibility description in respective ad to make your decision.



You need a fully accessible accommodation.

The accommodation has accessible bathrooms and toilets, as well as wide door widths. You will not face more than eventual small thresholds of a maximum of 3 cm (1 inch), and the accommodation will accommodate wheelchair users. 

Conclussions

Social economy is enhanced by different private and formally-organised entities

 There have emerged new organizations capable of growing exponentially, known as startups.

o There is an increase of startups that have purely **social objectives**, in line with the SDG.





- The total investment on startups has significantly increased in the last five years.
- The funds received for healthcare startups occupies the third position of the total investment

- It is highlighted the funding received by biotechnology and drugs development startups
- Through the investment in startups, social economy practices are gaining greater recognition, by promoting social awareness and the development of social, cultural, economic and financial activities
