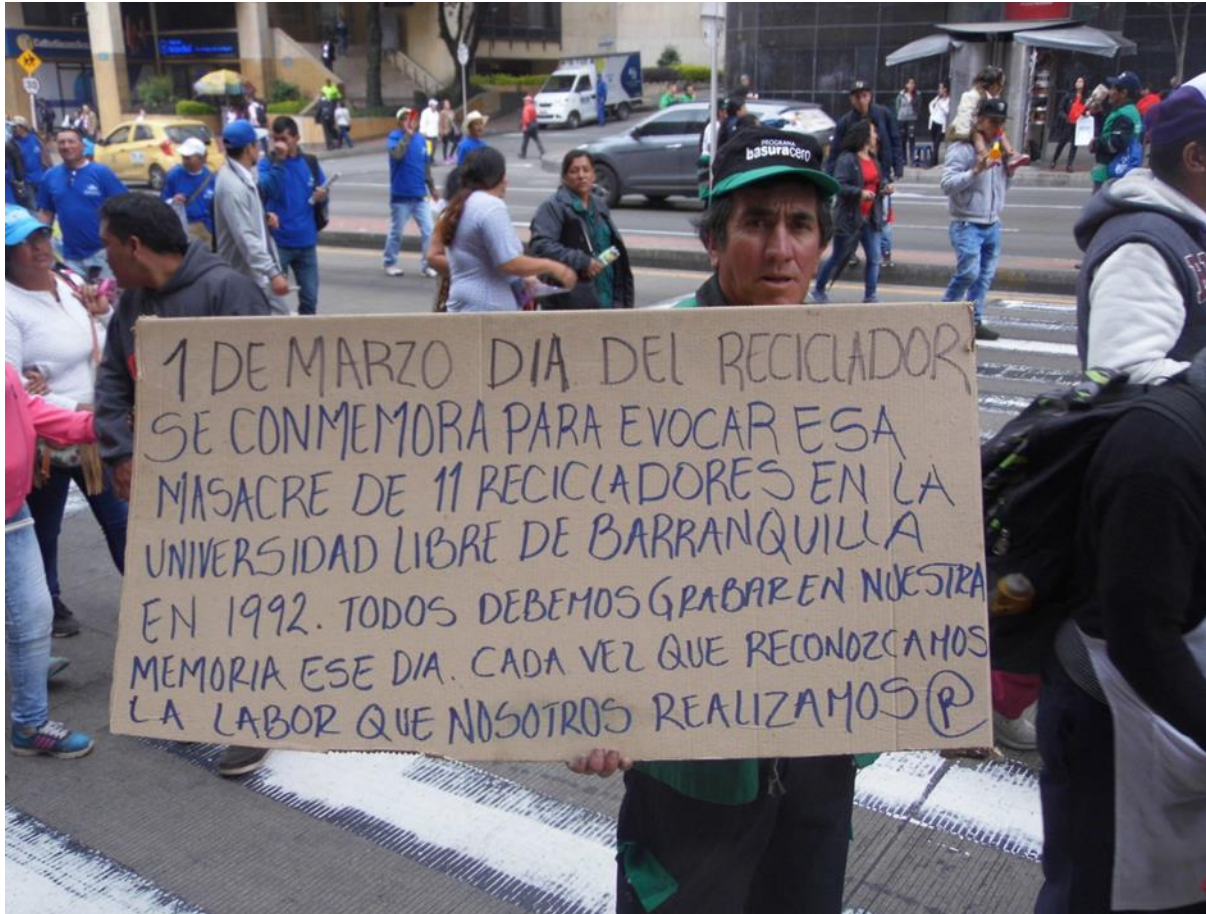

Solid waste management as urban commons



Three big lines to approach to the common goods and the common

1. ***Community regards from the institutional economy*** (Cárdenas & Ostrom, 2004; Ostrom, 2009a, 2010; Poteete, Janssen, & Ostrom, 2012)
2. ***The common not only as a resource, but as a search and existence of individual and collective welfare*** (Espósito, 2003; Esteva, 2014; Foster, 2011; Hardt & Negri, 2009; Mitlin, 2008)
3. ***From the political economy against the enclosures of capitalism*** (De Angelis, 2004; Escandell, 2015; Harvey, 2012; Hodgkinson, 2012; Lee & Webster, 2006).

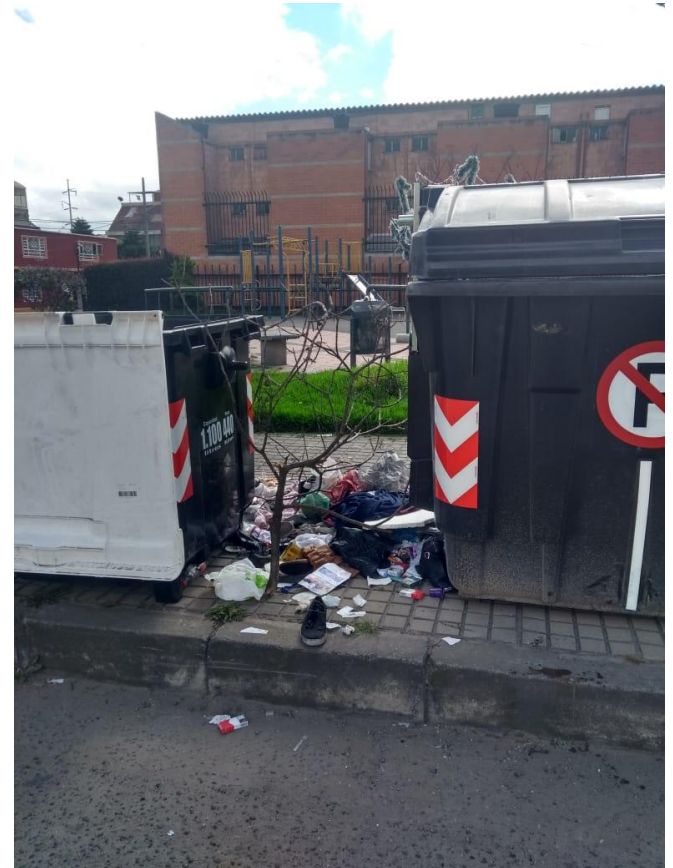
