

Spin-off Social (SOS)

- Transfer of knowledge and learning to the communities free of charge, the result is a value in social contribution and territorial development.
- Stimulate financial democracy in communities where the Social Progress Index indicators are low in social, environmental and economic variables.
- Innovation and transfer of technological resources. sources of work, with this model we have been innovating that, with scarce economic resources, by means of technological resource.


Spin Off Social (SOS)


Planned Social Spin Off Model

No tolls or return on investment 100% Seed Capital Accompaniment until reaching financial break-even point



Stages of the SOS in the accompaniment of communities

Identification and outreach and diagnosis of training and competency needs with the community

Formation of a pre-cooperative group and development of personal and group soft skills.

Development of hard skills, building social capital and the process of constructing the Feasibility, Viability and Utility Study.

Continuous training for members of the cooperative. Strategic management coaching and mentoring to the Board of Directors and management to break-even point. Construction of the cooperative's website with the support of UNED and support to ally to "market place".

Accompaniment process until the closure of the initial project and the possibility of generating new feasibility projects that generate greater profitability, in alliance with different government entities and the social banking system.




Constitution of the I Assembly for the creation of the Cooperative. Paperwork submitted to INFOCOOP and Ministerio de Trabajo

Stages of the SOS model and the programs that comprise them


