

## **Call for papers for a Special Issue “Gender approaches of Social Economy and State-Owned Enterprises”**

### **Themes and contents of the special issue**

Growing inequality, precarious working conditions, the climate crisis, the loss of democratic capacity and the increase in territorial violence are some of the major global challenges of our time. In many cases, women and gender minorities are at the heart of these issues, both as victims but also as promoters of alternatives to curb the risks involved. The social economy and state-owned enterprises share a social and public mission to transform the economy, its methods and its outcomes, so that it serves sustainability and improves the well-being and empowerment of people, communities and territories in the economy. What roles do women and gender minorities play in the orientation, governance and management of such organizations? Following feminist economics, how do these enterprises “challenge the gendered frameworks of economic theories and generate knowledge for a more just and sustainable world, while bringing broader transdisciplinary visions” (Bergeron, 2023, p.37). There are many similarities between feminist economics and the practice and theory of social economy and state-owned enterprises (Baruah, 2023; ILO, 2010 and 2015, OECD, 2023; Pavlovic et al. 2023). However, there are still many challenges to be faced as shown by Bastia et al. (2022), Guerin et al (2021), Hillenkamp and Dos Santos (2019) and Lesnikov et al. (2023).

We propose a special issue that focuses on social economy and state-owned enterprises, identifying the spaces, challenges and opportunities these organizations share from a gender perspective. We believe that in order to provide evidence and knowledge based on both quantitative and qualitative techniques, analyses from different disciplines such as economics, sociology, law or history are necessary. We propose the following areas of research:

- Deepening the articulation between social economy and feminist economics, identifying the factors limiting gender equality in social economy from a multidisciplinary perspective in the search for transformative and cross-cutting practices beyond the gender system.
- Analyzing the challenges for social economy organisations in the area of gender inequality, including vertical and horizontal segregation, pay gaps and other relevant issues. The aim is not just to quantify these concepts, but also to understand in detail what the key factors are that promote or hinder effective equality within these organizations. Identifying the levers that can help or hinder the achievement of gender equality in SSE is therefore a priority.

- Measuring the impact of policies and practices introduced to reduce inequalities. The definition of critical indicators and the measurement of their evolution over time, based on a longitudinal approach, will make it possible to demonstrate the progress that making in favour of gender equality and to identify and understand the key elements that have a greater impact on this evolution.
- Addressing success factors and failures of female representations in the governing bodies of public enterprises on all government levels (national, regional and municipal enterprises).
- Analyzing and evaluating the approaches of “doing gender” in the light of public sector’s commitments towards the Sustainability Development Goals (SDGs), the OECD Principles for gender diverse boards of state-owned enterprises and national regulatory frameworks for promoting the democratic principle of gender equality.
- Taking stock of how gender issues are addressed in SDG-reporting, sustainability reporting as well as the gender-related management practices of state-owned enterprises in OECD-countries and non-OECD countries.
