NEW TRANSVERSAL WORKING GROUP

Proposal by Dorothea Greiling

Measuring the SDG impact in the Public and Social & Solidarity Economy

➤ Thematic subgroups on specific topics: e.g.

- Understanding the PE/SSE specificities that favor SDG implementation and measurement: mission of general/collective interest, participative and/or democratic governance, transparency and accountability
- PE/SSE contributions to specific sectors (e.g., agriculture, energy, health, housing, tourism), fields of actions (climate change, circular economy) or to specific SDGs (poverty reduction, gender equality, responsible consumption and production, etc.)
- Ecosystemic perspective to SDGs: territorial approaches, cross-sectoral partnerships and collaborations
- Measurement issues: identifying appropriate indicators (e.g., SDPI), scaling from micro to macro impact measurement


