Jérôme Dupras is Quebec's Chief Scientist and President and CEO of the Fonds de recherche du Québec (Quebec Research Fund). Prior to his appointment, Mr. Dupras was a full professor in the Department of Natural Sciences at the Université du Québec en Outaouais and held the Canada Research Chair in Ecological Economics and the UNESCO Chair in Biodiversity Economics.

Throughout his career, Jérôme Dupras has received numerous distinctions, including the Governor General's Academic Gold Medal, the Medal of Honour of the National Assembly of Quebec, and the National Order of Quebec.

Julia Cagé

A graduate of the École Normale Supérieure and holder of a doctorate from Harvard University, Julia Cagé is Professor of Economics at Sciences Po Paris and an affiliated researcher at the Centre for Economic Policy Research (CEPR), where she directs the Media Plurality Research Policy Network, as well as at the Interdisciplinary Laboratory for the Evaluation of Public Policies (LIEPP) and the CESifo Research Network. A specialist in political economy and economic history, she focuses on the media, particularly the impact of competition and the introduction of the internet on the quality of information produced and political attitudes. Her research also examines the financing of democracy, especially political parties and election campaigns, in Western Europe and the United States, from a comparative perspective.

Her work has been published in leading economics journals, including the American Economic Review and the Review of Economic Studies, as well as in numerous edited volumes. She is the author of several books translated into around fifteen languages, including **Saving the Media: Capitalism, Crowdfunding and Democracy** (Le Seuil, 2015), which received the Special Jury Prize at the Assises du Journalisme (2016), and **The Price of Democracy** (Fayard, 2018), which received the Anticor Ethics Prize (2019), the France Culture-Le Monde Petrarch Essay Prize, and the City of Saint-Maur Essay Prize (2021). Her latest book, **A History of Political Conflict: Elections and Social Inequalities in France, 1789–2022**, co-authored with Thomas Piketty, was published by Seuil in 2023.

In 2021, she held the “Arne Naess Chair in Global Justice and the Environment” (University of Oslo). In 2023, she received the Best Young French Economist Prize, and in 2025 the Yrjö Jahnsson Prize for the best European economist.
